

## HOW THE CONGREGATIONAL CARE SYSTEM WORKS

Watts Chapel stresses membership at our church. There are a number of reasons for this, but one of them is very practical. Membership helps us care for people. Without membership it is hard to know who is really a part of our church and who is passing through or just floating around. However, when someone joins the church we know this person is committed to our body and we need to be committed to him or her.

WCMBC Tribal Care Leaders (TCLs) are responsible for maintaining regular/periodic contact with members assigned to their care. TCLs are requested to contact each household in your tribe once every four (4) months with a minimum of five (5) families being contacted every week.

## Acceptable contacts include:

- Phone calls
- Face-to-face meetings
- General emails
- Emails that are sent to members to which the member does not respond are not acceptable contacts. Once the member responds with their status update, the contact is acceptable.
- Group fellowship

In addition to regular/periodic contact of members under the TCLs responsibility, the following member contacts are expected:

- New member(s) should be contacted within a week of joining the
- New member(s) should be contacted the week of/after receiving the Right Hand of Fellowship and/or Baptism.
- Members who are sick, shut-in or hospitalized.
- Members experiencing a crisis.

Members will share in some of the responsibility to help the system function properly. Members are expected to contact their Deacon under the following circumstances:

- Pending hospitalizations
- Deaths in the family
- Births and /or pending baby dedications
- Moving out of the area and/or leaving WCMBC
- Members who are sick or facing crisis
- Positive celebration (graduations, weddings, anniversaries)

\*If any personal information of a member is incorrect, please contact the administrative office/Church Clerk identifying the correct information.
